WAIVER and RELEASE

In consideration of my registration to bicycle in the Greater Kingston Kiwanis, a WA non-profit corporation, (hereinafter GKK) Bike Fest event or my participation in any part thereof, I hereby agree and acknowledge the following, which includes a release of liability, which will apply to all of my participation in the GKK Community Bike Fest (individually, and "Event", and collectively "Events (parts)"):

1. I am aware that with bicycle related event activities there are certain inherent dangers, including but not limited to the hazards of roads, off roads, off road terrain, accidents, action of other participants and other persons. By participation in the Event, I certify that I am aware of these inherent dangers of bicycle riding and safety rules of specific events applicable to bicycles.
2. I understand that certified bicycle helmets are required to participate in all riding Events and I agree to wear a helmet while participating in any such Event and to follow the rules of the road, common sense and specific event rule and all applicable laws and safe bicycling practices.
3. I hereby consent to emergency medical treatment if injured while participating in an Event.
4. I understand that it is not the function of the event leaders or organizers to serve as guardian of my safety, I recognize that the event chosen may be challenging, not necessarily the safest or easiest route(s) or events, and that weather, and other conditions may make an event difficult. GKK reserves the right to remove any rider who is deemed to be endangering himself/herself or others or is acting unsafely, illegally or recklessly. Notwithstanding this clause, GKK is not responsible for cyclists not removed from the Event for any of these reasons and this clause shall in no way supersede, exempt participants from, or otherwise nullify any clause in the Waiver & Release.
5. I give permission to GKK to use my image without payment in any future GKK materials should it appear in photos taken during an Event.
6. I freely and voluntarily accept all risks of injury, death, or property damage. I understand and agree that none of the parties described below may be held liable in any way for any occurrence or accident in connection with an Event. I hereby RELEASE from any and all liability and agree to INDEMNIFY AND HOLD HARMLESS GKK, their officers, agents, successors and assigns, the sponsors, the event leader(s) (if any), or other volunteers, against all claims, including, but not limited to, claims of negligence, unintentional acts, and acts of omission, and any loss or expense, which may arise from my participation in any Event. I understand I am responsible for my own conduct and decisions while participating in a GKK Event and further agree that this Waiver & Release shall apply to any claim arising out of my participation in non- bicycling activities while a participant in an Event.
7. This Waiver & Release is intended to be binding upon me, my family, my heirs, my estate, my legal representatives and assigns. Any legal action that may arise from my participation in the ride or event will be brought in Kitsap County Superior Court in Washington State. I understand that the terms of this document as my own free act.
8. GKK is not be responsible for any delay, interruption or other failure to perform, and may cancel any event in its sole discretion.
